# Rural Development Program 2007- 13

## According to:

- COUNCIL REGULATION (EC) No 1698/2005 of 20 September 2005

on support for rural development by the European Agricultural Fund for Rural Development ([EAFRD](#)). **Article 39/Par. 3;**

-Structure of the program:

**Axes No 1 - Competitiveness - investment, education, marketing...**

**Axes No 2 – Environmenta - Agri-environmental schemes (Organic Farming, Integrated production, Natura 2000, FWD areas,...), Forest-environmental schemes**

**Axes no 3 – Rural development , renovation of small villages, diversification...**

**+ LEADER program – Local action groups**

Minimal distribution of EU funds (co-financing): 10%//20%//10%//2,5%

Project payment or area payments according to special condition



# Integrated production in RDP-conditions

**IP description in RDP 2007-13...**

**„Integrated production is oriented to the controlled cultivation of vine, fruits and vegetables, preferring ecologically safer methods, minimizing side unwanted effects, by reducing the number of fertilizers and plant protection products use and thereby by increasing the safety for environment (soil, water, and air) and human health.“**

**IP is focused on analyses of soil/leafs/fruits (heavy metals) and monitoring of pests ...**
